

# 43rd U.S. Handball Association National One-Wall Championships

July 31-Aug. 3 in Brooklyn, N.Y.      Entry deadline is July 14

- Site:** Surf Avenue and West 5th Street, Brooklyn, N.Y. In the event of rain, the tournament will be held indoors, probably at the Hebrew Educational Society, but go to outdoor courts first.
- Entry fee:** **Open events:** \$50 per person for first event, \$35 for second event. **All other events:** \$35 per person for first event, \$20 for second event. Special \$25 entry fee for juniors and college students (\$10 for second event) under age 23. **\*\*Special entry fee not applicable for prize-money events.** Maximum of two events.
- Deadline:** Entry must be in our possession by midnight, July 14. Visa/MasterCard entry available for additional \$10 by calling 520-795-0434.
- Mail entry:** Make check payable and mail to USHA One-Wall, 2333 N. Tucson Blvd., Tucson, AZ 85716.
- Awards:** There will be \$4,000 in prize money. Open events will have cash prizes and awards to first two places in championship categories. First-place award in consolation events. All other events will have awards for first two places in championship events and first in consolation.
- Eligibility:** Open to all current USHA members who meet age and skill requirements. Current USHA one-wall rules and regulations will apply. Players entered in two events must be prepared to play back-to-back matches. Losers must referee next available match. **Eye protection is mandatory.**
- Check-in:** Players should plan to arrive in plenty of time before their first match to allow for parking and traffic.
- Start times:** Call the USHA one week before tournament. Times will also be posted at [www.ushandball.org](http://www.ushandball.org).
- Hotel:** Golden Gate Inn, at Knapp Street and Shore Parkway, Brooklyn, N.Y., 11235. Phone: 718-743-4000.
- Attractions:** Brighton Beach, free Concert at Sea Side Park on Thursday night. Free fireworks show visible from boardwalk at 9 p.m. Friday. New York Aquarium, Coney Island Amusement Parks and Brooklyn Cyclones minor-league baseball.
